2. The Employer invites sealed bids from eligible firms or persons licensed by the Pakistan Engineering Council in the C-A category for the Works. International Competitive Bidding (ICB) will be conducted in accordance with Single Stage-Two Envelope (SSTE) procedure. A foreign Bidder is entitled to bid only in a joint venture with a Pakistani constructor in accordance with the provisions of PEC Bye-laws. 2. Flicible Didden when the information is provided and the provisions of PEC Bye-laws.

A complete set of Bidding Documents may be purchased by an interested Bidder on submission of a written application to the above office, and upon payment of a nonrefundable fee of PKR 20,000/- (Pak Rupees Twenty Thousand only) or US\$ 70/- (US Dollar Seventy only) from the date of publication of Invitation for Bids (IFB). The method of payment will be in the form of pay order or bank draft from any scheduled bank in Pakistan in favor of "INDUS TELEMETRY IBIS WAPDA LAHORE".

All bids (Technical) must be accompanied by a Bid Security of **PKR 300,000/.** (Pak Rupees Three Hundred Million only) or an equivalent amount in a freely convertible currency. The Bid Security shall be at the Bidder's option, either in the form of an unconditional bank guarantee from a reputable scheduled bank in Pakistan or in the form of CDR/Pay Order/Demand Draft. In the case of Bank Guarantee, the Bid Security shall be submitted using the prescribed form of the Bidding Documents. The Bank guarantee shall be issued by a Scheduled Bank in Pakistan or from a foreign bank duly counter guaranteed by a Scheduled Bank in Pakistan in favor of the Employer.

5. The bids must be delivered to the office of **Chief Engineer/ PD, Indus Telemetry, IBIS Project WAPDA**, 5th Floor Room No.536, Wapda House, Lahore, Pakistan on or before **10:30 AM** on **March 26, 2024**. The Technical Bids will be opened at **11:00 AM** on the same day, in the presence of Bidder's representatives who choose to attend at the same address. The Price Bids will be kept in safe custody and Price Bids of only technical responsive bidders will be opened.

The bidders must quote for the complete Scope of Work. Bids covering only a part of the work shall be rejected.

7. The Employer reserves all its rights regarding rejection of bids as defined in Clause 33(1) of PPRA Rules 2004.

8. The local bidders i.e., original manufacturers/ distributors/ suppliers/ contractors etc. must be registered with Income Tax & Sales Tax Departments.
