



## INVITATION TO BIDS

### **SUB:-TENDER FOR APPOINTMENT OF CHEMIST FOR THE YEAR 2023-24.**

1. WAPDA Hospital, Mangla Dam Organization invites sealed bids/tenders (Technical & Financial) for the appointment of chemist on free delivery to consignee's end for Financial Year 2023-24.
2. The bidder must be registered with income tax and sale tax department and on active tax payer list (ATL) of FBR at the time of submission of the bidding documents.
3. The firm having valid licensed from respective drug regulatory authority / registered drug manufacturing firm/ importers of drugs may participate in the bidding process for their product.
4. Bidding shall be conducted through single stage - two envelopes bidding procedure of PPRA Rules 2004. The two envelopes shall be marked separately as "FINANCIAL PROPOSAL" and "TECHNICAL PROPOSAL" in the bold and legible letters. The outer envelope shall clearly be marked with WAPDA Tender Enquiry No. alongwith subject for which proposal is submitted. Financial Proposal of Bid found technically non-responsive shall be returned alongwith pay order/demand draft to the respective bidders"
5. Bid Security amounting to Rs:50,000/- in shape of CDR/ Pay Order / Demand Draft is required to be deposited with the Technical Proposal.
6. The Bidding Document containing detailed terms and condition can be purchased from the office of MS WAPDA Hospital Mangla on payment Rs.2000/- (as Non Refundable tender fee) within office working hours"
7. Sealed bids are required to be submitted by the bidders on **24.04.2024 at 1100 Hrs** positively in the office of MS WAPDA Hospital Mangla. The technical proposal shall be opened on the same day at **1130 Hrs** in the presence of the bidders or their authorized representative who choose to attend. Late submitted bids shall not be entertained.
8. In case the date of opening or last date of sale of bidding documents is declared as a public holiday by the government or non-working day due to any reason the next official working day shall be deemed to be the date of submission and opening of tenders accordingly. The time and venue shall remain the same.
9. Competent Authority reserves the rights of rejection or acceptance of bids as per PPRA Rules 2004.
