



- Copy of Income Tax Registration Certificate (NTN). The firm must be an e-filer, (proof must be provided from FBR), non e-filer firm will not be entertained.
- Copy of National Identity Card (original must be provided at the time of submission of application)
- Copy of PEC enlistment / registration in the relevant category & financial limit.
- Application should be written on pad duly signed with date.
- Tenders will be issued to the proprietor of the Firm/Company or their legally authorized representatives having registered power of attorney (duly attested).
- Bid security in the shape of Deposit at call/CDR @ Rs.600,000/- for each work in the favor of Executive Engineer, Central Civil Division-III, Pak. Public Work Department Islamabad issued by any scheduled bank of Pakistan from the account of applicant/firm must be submitted.
- Undertaking on stamp paper of Rs. 100/- that the firm / contractor has neither abandoned any work nor black listed in any Department, along with Certificate that the particular / information furnished are true and correct duly signed by the Notary Public.
- The CDR must have a date of issuance after invitation of tender notice in newspaper and on or before tender opening. No CDR having a date of issuance prior to invitation of tender will be accepted.
- No tenders will be sold/received by post/telephonically or E-mail on the date of opening of Tender.
- All CDRs once received will be credited into the Government Account, and will be refunded through Government Cheque after its crediture in Government Account.
- The submission of tender by the contractor implies that he is fully conversant with the site of work, scope of work and terms and conditions laid down in the tender documents.
- Under rule 33 (i) of Public Procurement Rules, 2004. Pak PWD reserves the right to reject the bids at any time prior to the acceptance of bid.
- In case of quoting rates below than the NIT value, the bidder will have to provide additional Performance Security in the form of CDR for the respective work equal to 10% of the NIT Amount for the respective work in the favor of Executive Engineer, Central Civil Division-III, Pak. Public Work Department Islamabad issued by any scheduled bank of Pakistan (must be enclosed in the sealed envelope containing bid). In case of failure, and if the same not found in the sealed bid at the time of opening, the bid will be considered as non-responsive and will be rejected.
