

05: Contractor born on approved list of MES in category 'A' 'B' 'C' & 'D' and also having experience of this type of work may apply.

06: Contractors who desired may present at the time of opening of tenders.

07: The accepting officers reserve the right to accept or reject the tender. Rejected tenders will-be dealt with as per Para 33(i) of PPRA Rules.
