## INSTRUCTION TO THE BIDDER

- 1. The contractors/bidders are advised to visit & examine the above 3x sites of work and its surroundings well before submission of bid.
- 2. Rate to be quoted against the scope of work as 01 Job in accordance with the detail provided above in the table.
- 3. The basis of payment will be the actual work executed and carried out, as given by contractor and verified by the Engineering staff of WCB. The contractor shall not raise any claim in case of decrease or increase in the scope of work at site.
- 4. All kinds of de-silted material recovered from disposal station shall be disposed off by the contractor outside the Cantonment Limit, in a secured and environmental-friendly manner, at his own risk & cost.
- De-silted material shall not be dumped on the road and will be simultaneously loaded into the vehicles for disposal.
- 6. Work order will be issued to the lowest bidder after approval of the Board within 180 days of receipt of bid.

- Presence of Technical staff/supervisor of contractor is mandatory during course of de-silting work.
- 8. The Contractor should submit the execution plan before start of the work in the light of work order.
- 9. The contractor shall ensure all the safety / precautionary measures to avert any incident or inconvenience to the motorists / pedestrians.
- 10. In case of any damage to the infrastructure, pumps, chamber or well during course of de-silting, the contractor shall be bound to fix the same at his own.
- 11. All arrangement for standby pumps, disposal of sewage will be responsibility of contractor prior to execution of work

## **TERMS & CONDITIONS**

- 1) Interested bidders can only submit their bids online through e-Tender Portal of ML&C Dept (https://etender.mlc.gov.pk).
- 2) Contractors having valid NTN No, STRN No are eligible to apply.
- 3) The cutoff time for submission of online bids will be 1400 hrs dated 28 /03 /2024 and shall be opened on same day at 1430 hrs electronically on the portal. The contractors will be able to see the comparative statement online.
- 4) If for any reason, office remains closed on the date of quotation, it will be opened on next working day.
- 5) The CDRs from scheduled bank uploaded online shall be deposited in the office of Cantt Board Walton on the same day of opening of bids. In case of failure the bids submitted will be rejected.
- 6) Quotation without attachment of call deposit in favour of the undersigned will be rejected.
- 7) The issuance of work order shall be subject to approval from Board.
- 8) The validity of quotation rates shall be upto 180 days.
- 9) Bidder who provides incorrect information shall stand disqualified and will be debarred under rule 19 of the PPRA Rule 2004 (as amended).
- 10) The successful contractor shall sign the agreement with the procuring entity within 10 days after acceptance of bid.
- 11) Quoted rates shall be inclusive of all applicable govt. (federal / provincial taxes).
- 12) Contractor / bidder blacklisted by Cantt Boards or involved in litigation or found to be indulged or fraudulent practices will be considered non-responsive by CB Walton being procuring entity.
- 13) Any bid received in contravention of enabling provisions of PPRA rules, 2004 will be declared non-response by the Board being procuring entity. Cantt Board Walton reserves the right to accept or reject any e-bid on technical / administrative grounds under rules 31 (I) of PPRA rules 2004 (as amended up to date).
