Reference our previous tender hoisted on PPRA by 04.01.2024 (TSE No. 526777E) and published in print media, PID No. (I) 3411/23 dated 05-12-2023 (Dawn, Ausaf, Al Jalal Sgd and Azmat Lahore), the previous advertisement was cancelled due to vendors' inability to register on EPADS. **The office is re-initiating this Invitation for Bids for Procurement of VDI Solution in lots.** The Project Director Implementation of Online Billing Solution intends to procure the following VDI solution in Lots under the Public Sector Development Program approved by the Central Development Working Party (CDWP) of the Ministry of Planning, Development and Special Initiatives through Project Concept [Implementation of Online Billing Solution 'Sehal'] under the Public Financial Management reforms at Federal and Provincial Levels:

Lot-1- Procurement of Desktop Computer Systems and LEDs-QTY 250

Lot-2- Procurement of 1200 VA/1000 Watts UPS for Desktops Qty-250

Lot-3-Procurement of Virtual Desktop Infrastructure Solution for AG Office Lahore, Karachi, Peshawar, Quetta and AGPR, Islamabad with 1000 Concurrent user licenses and 1000 Zero/Thin clients for 05 Locations (QTY 01-Turnkey Solution)

2. The Procuring Agency has reserved the funds for the procurement planned during the financial year [2023-24] under the Public Sector Development Program. This office intends to apply part of the proceeds of the grant to cover eligible payments under the contracts for the **Lot-1, Lot-2 and Lot-3.** The Project Director Implementation of Online Billing Solution now invites separate sealed bids from eligible Suppliers of above mentioned lots 1 to 3 to **supply within 08 weeks to 24 weeks and submission of separate sealed bids through Electronic-Pak Acquisition & Disposal Systems (E-PADS).**

3. The bidding shall be conducted in line with the **Single stage one envelope** procedure of the Public Procurement Rules 2004 and any Regulations, Regulatory Guides, Procurement Guidelines or Instructions issued by the Authority (from time to time), and is open to all potential bidders who may submit separate bids for above lots on their choice. The procuring Agency shall award or cancel Bid under Lot-1, Lot-2, Lot-3 in accordance with the Public Procurement Rules 2004 and E-Pak Procurement Regulations, 2023.

4. **Pre-bid meeting/E-PADS orientation session** will be held on 02.01.2024 at FABS Directorate, 2nd Floor, starting from 09:00 A.M. All bids must be accompanied by a **Bid Security (2% of the Estimated bid price)** in favor of DDO (SEHAL), DG MIS, CGA as per PPRA Rules, 2004 on prescribed format given under the bidding document with **bid validity period of 180 days.** The Procuring agency shall separately award or cancel contract under lot-1, lot-2, lot-3 or all lots in accordance with the Public Procurement Rules, 2004.

5. **All bidders must resolve their E-pads related issues, including registration and bids submission with PPRA at their end 03 days before closing date (on or before 12.02.2024) and no excuse will be accepted whatsoever in this regard.**
