

03. Firms / Contractors borne on approved list 'E' of MES Contractors or the Government Departments having experience of this type of work may only apply. The contractors will also furnish valid registration certificate of Pakistan Engineering Council, Bank Statement / GST and NTN certificate.

04. Contractors who desire may be present at the time of opening of tenders.

05. Tender documents will be provided after issuance of publications.

06. The accepting officer reserves the right to accept or reject the tender. Rejected tenders will be dealt with as per para-33 (1) of PPRA Rules.
