## Invitation for Expression of Interest for Capacity Enhancement of Amine Gas

Sweetening Unit at one of PPL's Hydrocarbon Processing Plants PD/DTS/PT/27323/24 Pakistan Petroleum Limited (PPL) is a leading exploration and production company of Pakistan. As a major supplier

of Natural Gas, PPL today contributes about 20 percent of Pakistan's total Natural Gas supplies besides production of Crude Oil, Natural Gas Liquid and Liquefied Petroleum Gas.

Expression of Interest (EOI) is invited from wellestablished, experienced and reputable organizations for enhancement of production capacity of one of PPL's hydrocarbon processing plants, installed/commissioned a few years back with a designed throughput of 55MMscfd. The Plant is currently operating efficiently at its designed capacity and comprises of Amine-based Acid Gases (CO $_2$ /H $_2$ S) removal unit (from 25Mol% CO $_2$  to <3Mol % CO<sub>2</sub>), hydrocarbon dew point control unit, LPG extraction

PPL intends to enhance the capacity of Plant's Amine Gas Sweetening Unit up to 100 MMscfd with minimal cost exposure by replacing existing solvent and trays with licensed solvent and column trays technology. This is to be noted that EOI / proposal for capacity enhancement by means of additional parallel Amine Train or Used/ Refurbish Amine Package should not be entertained/ allowed/applicable. Interested parties having proven record and capability of

services/ supply in capacity enhancement specifically through upgradation in Amine Gas Sweetening Unit should submit their EOI by 15:00 hrs on Tuesday, April 16, 2024, along with the required documents as entailed
