The interested bidders persons must submit a call deposit / pay order bank draft of 0.333 million to participate in the bid as an earnest money in the name of XEN B&R Division Skardu. The successful bidder shall be liable to deposit advance government taxes in addition to offered price. The bidder shall provide his complete address / telephone number along with a copy of national identity card NTN and GST registration certificate. (GB Bidders exempted only)
- d) The successful bidder shall have to deposit 35% of the offered price / bid in cash on the spot and remaining 65% amount deposited before final collection of scrape from workshop Skardu.
