NOTICE FOR CANCELLATION OF TENDER

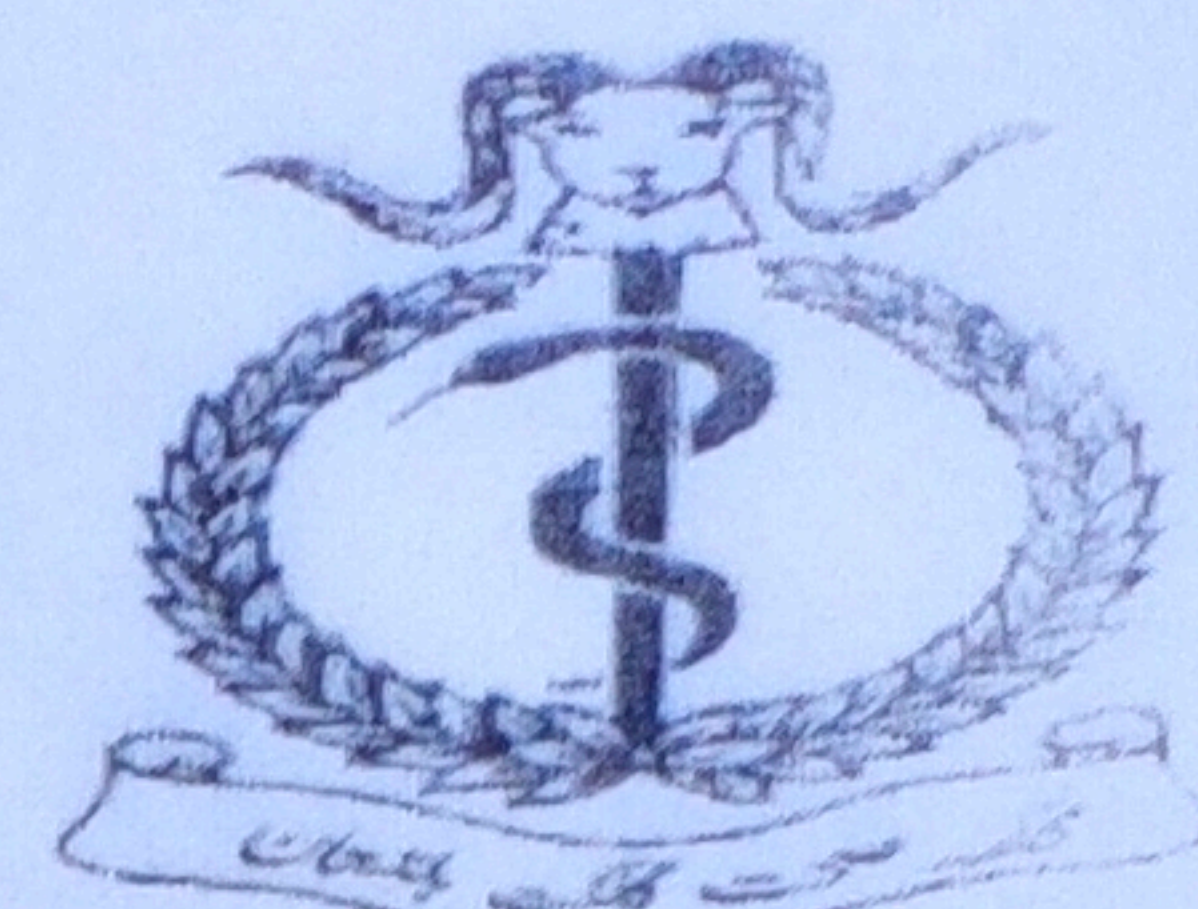
