- (3) No columns should be left blank in quotation, however, "NQ" should be written in column for **Items Not Being Quoted**.
- (4) Delivery period of the quoted stores must be mentioned in your quotation.

- b. The purchaser will reject all bids or proposals at any time prior to the acceptance of a bid or proposal.

7. **Importance Note**


- a. Delivery period will be 15 days after the award of contract, failing which contract may be cancelled.
