The tenders may be dropped in the tender box marked as "**Tender Box Disposal Section**" placed at the entrance of the PIA Procurement & Logistics (Store) Building latest by **10:30 hours** on the specified date. Bidders may also send tenders through registered A/D, or through email which must reach before the closing date and time mentioned above.
