

**TORs FOR SUBMISSION OF RATES OF DIFFERENT ITEMS REQUIRED FOR
ELECTRICAL/CIVIL WORKS OF FBR HOUSE, ISLAMABAD.**

1. The successful contractors/firms will ensure to arrange and supply all items etc in the premises of FBR (HQs) Building, Constitution Avenue, Islamabad within the stipulated period.
2. The Firm/Supplier /Contractor shall be locally based i.e Islamabad/Rawalpindi.
3. In case of any sub-standard items, the contract shall be terminated forthwith, forfeiting security money in favour of the Government.
4. The tender shall be accompanied with item-wise rate (inclusive of all taxes).
5. The contractors/firms shall be registered for Sales Tax and Income Tax, duly supported by copies of STRN and NTN Certificates. The bidder shall also be on Active Taxpayer List (ATL) of FBR.
6. The contractors/firms shall have vast experience of supply electrical/civil items to the Government Departments/Private Organizations, duly supported by copies of required experience certificates.
7. Bank Draft/Pay Order @ 5% of the quoted price of all items, as security money in favour of DDO, FBR (HQ), Islamabad, shall be attached with the tender.
8. Initially the contract will be made for one year, extendable/renewable up to three years subject to satisfactory supply and on original /initial quoted rates.
9. The successful contractor/firm shall not have any claim of expenses on account of increase in the prices during the period of contract.
10. Payment(s) shall be made on satisfactory delivery of items.
11. Bidder firm shall attach an affidavit of Rs.100/- stamp paper (latest and original) to the effect that the firm has not been black listed by any of the Govt. Department/Agency. If this certificate is found to be bogus or false, appropriate action against the firm shall be taken including forfeiting of security.
12. No bid shall be entertained after given cut-off date and time.
13. The procuring agency reserves the right to reject any or all bids under Rule-33 of PPRA Rules, 2004.
