3. A bidder may **require to bid for entire (100%) items/quantity**. Conditional or incomplete bid will not be accepted. Evaluation and comparison of bids for 100% quantity shall be carried out. Award of Contract shall be made on entire (100%) items/quantity.

4. **Single stage-one envelope** procedure shall apply as specified in the Public Procurement Rule (PPR), 2004 (as amended to date). Bids, duly accompanied by a “Bid Security” i.e. mentioned above table in shape of a Bank draft/Call Deposit/Demand Draft/Banker's Cheque in the name of **Senior Contract Management Specialist**, Project Planning and Development Unit (PPDU), MoWR, Islamabad, shall be delivered to the address given below on or before **24th May, 2024 at 1100 hours**. Electronic bidding shall not be permitted. Late bids will not be accepted. Bids will be publicly opened at **1130 hours on the same day** at the address given below, in the presence of the bidders’ designated representatives, who may choose to attend.

5. The bidders are requested to give their best and final prices inclusive of Indirect Taxes & Transportation, Installation and Commissioning charges etc as no negotiations on the prices are allowed. PPDU may reject all bids at any time prior to the acceptance of a bid by invoking rule 33 of Public Procurement Rule (PPR), 2004. In case public holiday is announced on bid submission & opening date the same shall be held on the next working day.
