a) Tender form shall be issued to the contractor/ firms in person on production of original CNIC, PEC Certificate Valid Up To 30th, June 2024 Or Renewal Fee Receipt 2023-2024.

b) Contractor/ firms shall provide 02% E/money of estimated cost in shape of deposit at call in the name of **Director Water Management & Irrigation GB**, from any schedule bank of Pakistan.

c) Overwriting on bidding documents is not allowed and incase of any overwriting/omissions is found, the bid shall be rejected.

d) Contractor/ Firm shall provide certificates of no litigation, no nay sick project with any other Govt. Department.

e) Rate quoted below of the Technical Sanction shall be considered as unworkable, however:-

• The bidder quoting rates below 10% of the TS amount shall be required to provide along with his bids an additional performance guarantee of 50% of the differential amount (between TS and Bid) in shape of CDR.

 In case of failure to produce the required differential amount of the bid by the bidder along with his bid documents, the bid shall be rejected.

Conditional bids will not be accepted/entertained.

g) In case of Gazette holiday/ Local holiday, tender shall be opened on next working day without further intimation.

No bid shall be accepted beyond closing time as mentioned against work.

i) The bid prepared for the above work should be in accordance with the instructions contained in the bidding documents and must be submitted in the office of the Director Water Management GB before closing date and time. Envelop marked "Technical Bid" will be opened at above mentioned due date at 11:00 AM in presence of contractors or their authorized representatives and Financial bids of only technically qualified bidders will be opened.

j) Pre-bid meeting will be held on 18<sup>th</sup> April, 2024 at 1100 hours in the office of the Director Water Management &

k) Tender shall be awarded to the contractor/ Firms on the basis of cumulative lowest financial bid offered by the prequalified bidders.

Power of attorney for bidding should be in RS-100 Stamp paper in original mentioning the project name with employee stamp.

 The procuring agency may reject any or all bids at any time prior to the acceptance of tender under the provision of PPRA Rules without assigning any reason.

o) The already applied firms/ Contractor shall be allowed to obtain new bid documents from the office of the undersigned through production copy of fee receipt and other required documents during the above mentioned period.
