

- iii. The workshop should be registered with Sales Tax and Income Tax Department. (Valid documents must be attached).
- iv. Affidavit regarding Non-black listing of workshop/firm on stamp paper at least of Rs.100/- value may be attached with bidding document.
- v. The procurement of tyres of various vehicles will be awarded to the most advantageous bidder in terms of Rule 36(a) of Public Procurement Rule-2004 on fulfillment of criteria.
