### EXPRESSION OF INTEREST (EOI) FOR PREQUALIFICATION

#### PLANNING, DESIGN & SUPERVISION OF RAHEEL SHAREEF MEDICAL AND DENTAL COLLEGE CHAKLALA CANTT

1. Invitation for registration of Architect having at least 05 years experience and registered with PEC/ PCATP for pre-qualification (shortlisting) by Chaklala Cantonment Board for planning / designing of a Medical and Dental College Building in Chaklala Cantt is hereby extended. The major project components include;
  - a. Preparation of conceptual plan at least 3x proposals
  - b. Preparation of detailed Architectural and structural working drawings, after the finalization of proposal three dimensional architectural drawings, electrical / sanitary / air-conditioning / utility services / lifts / power backup / fire fighting and other services drawings related with the civil works etc.
2. **Required Information:** Interested architects are invited to register their firm for participation in the project implementation by sending the following information (as per PEC's & PPRA rules and regulations ) in quadruplicate;
  - a. Contact Information of the firm i.e. name, address, telephone, fax, email and mailing address of firm.
  - b. Ownership and organizational structure of the firm.
  - c. List containing names and short CVs of full time technical and support staff along with their qualifications and experience to be supported with proof of their employment.
  - d. List of major / similar assignments under taken during the last 05 years.
  - e. National Tax Number from FBR and Income Tax clearance certificate for the last 05 years.
  - f. Affidavit on a judicial stamp paper to the effect that the firm & its employees have never been blacklisted by any Government, Semi Government, Autonomous or state owned organization and that their cases regarding blacklisting are not under trial in any court of law.
3. **Disqualification:** Any wrong and misleading information provided by the applicant firm shall lead to disqualification of their proposal from competing in the above

project. If such wrong or misleading information is discovered after conclusion of an agreement / contract, it shall lead to cancellation of such agreement contract.

4. **Selection:** The deadline of receipt of EOI / applications is **Tuesday 12 September 2017**.
  - a. EOI / applications received after this date shall not be entertained. A list shall be finalized from the submitted applications.
  - b. Only the firms with demonstrated experience in similar assignments will be considered and notified for further participation in the selection process.
  - c. Final selection of the firm will be made after scrutiny of credential as per evaluation criteria.
