The tenders will be received at **01:00 PM on 12.02.2019** and will be opened on the same date at **02:00 PM** in presence of the contractors / their authorized representatives who care to be present at the time of opening of tenders. The following conditions will be observed while tendering process: -

1. The following documents shall be attached with the applications for purchase of tender failing which the tender will not be issued: -
 - a. Copy of Computerized national Identity Card.
 - b. Copy of Income Tax Registration Certificate (NTN Certificate).
 - c. Original enlistment / registration in the relevant category & financial limit along with attested photocopy.
 - d. Application should be written on letter pad duly signed with date.
2. The contractor himself or his representative duly authorized by him should participate in all tender process. The person whose name exists in Form-H / partnership deed will only be entitled to sign the tender form in case of partnership firm no proxy will be allowed on participate in the bidding.
3. The bidder will be required to give detailed analysis of workability of his bid if deemed necessary.
4. No tender will be sold / received by post / telephonically or email on the date of opening of tenders. In case of public holiday, opening will be changed to next working date.
5. Each tender must be accompanied with bid security @ 2% of the bid amount in shape of deposit at call from any Schedule Bank of Pakistan in favour of the Executive Engineer Central Civil Division Pak PWD Faisalabad.
6. Contractors have sufficient experience of building construction supported by the attested copies of work orders.
7. No tender will be entertained without bid security @ 2% of the bid amount or less than 2% of the bid amount.
8. The submission of the tender by the contractor implies that he is fully conversant with the site of work scope of work and terms and conditions laid down in the tender documents.
