

TERMS & CONDITIONS

- Tender forms, BOQ and Bidding Documents can be obtained from the office of the undersigned 5 days before of submission date. Tender form will only be issued to the contractors who are eligible in specialized code and to the sole owner / persons whose names are born on Form-H / Partnership Deed or Authorized Person of the Contractor duly Authorized by him in writing for a specific work.
- The contractors/firms are required to submit sealed bids clearly marked the name of the work on the envelopes.
- Conditional/Telegraphic tender shall not be entertained.
- Rate quoted by the contractors/bidders **more than 10% below** shall be rejected. In case of bids 10% below on CSR-2012 (Qtr-III), the contractor/bidder shall deposit additional 8% security within 5-days. If the lowest and successful bidder fails to deposit additional 8% security within specified period, his

- 2% Earnest money shall be forfeited and give order of acceptance to 2nd lowest or to the 3rd lowest bidder and so on, on the same term of forfeiture of Earnest money.
5. In case of tie of quoted rates, the financial bids will be decided on FREE TOSS at spot on the date of opening of bids.
 6. If the contractor/firm supplied incorrect information/documents, the defaulter shall be recommended to higher authority for disqualification and black-listing.
 7. **Rejection of all tender proposals:** Subject to approval by head of the procuring entity, the tender accepting authority may reject all tenders, proposals offers or quotations at any time prior to the acceptance of a tender, proposal, offer or quotation. However, before rejection of tender on basis of the bid being unworkable, the bidder shall upon request be given an opportunity to give a detailed analysis of workability of his bid.
 8. Any other information can be obtained in the office of the undersigned on any working day during office hours.
 9. The contractors shall quote their rates both in figures as well as in words.
 10. Bidding documents may be obtained from the Office of the undersigned on any working day before submission date.
 11. The application of the Contractors for the above works may accompany the following attested Documents.
 - i) Earnest Money in shape of Call Deposit from Schedule Bank of Kurram Agency Only.
 - ii) Enlistment Certificate of Contractor in Specialized Code of PEC and C&W Department Tribal Districts Peshawar.
 - iii) Renewal of Registration for CFY.
 - iv) National Identity Card.
 12. No Cutting in Tender Form will be accepted.
 13. Call Deposit of 1st, 2nd and 3rd lowest bidders will be retained till the approval of the Tenders from Competent Authority.
