- 9. Tender will be conducted under National Competitive Bidding pursuant to 'Single stage one envelope procedure' and is open to all eligible participants of tender that meet the following minimum eligibility/qualification criteria.
- 10. The envelope shall be marked as "Proposal for Rental Car Services" in bold and legible letters to avoid confusion.
- 11. Initially, the envelope containing proposal for "Rental Car Services" will be opened in presence of the bidders or their authorized representatives who may like to be present.
- 12. Later on, NICL shall evaluate the "received proposals" and will reject any proposal which does not conform to the specified requirements.
- 13. Affidavit on stamp paper worth of Rs. 100 that the company has never been blacklisted by any government/private department.
- 14. The bidder shall provide duly signed and stamped RFQ, terms and conditions, technical compliance sheet, any other requirements, etc. included in Tender documents & agreed to provide the services accordingly.
- 15. Evaluation criteria/guidelines are attached for the information of all participating firms.
- 16. Applicants are required to provide copy of CNICs of the owner(s) for AML (Anti-Money Laundering) and CFT (Counter Financing of Terrorism) clearance.
- 17. NICL shall notify all Applicants in writing of the names of those Applicants who have been prequalified / enlist or conditionally prequalified. In addition, those Applicants who have been disqualified will be informed separately.
- 18. NICL shall communicate to those applicants who have not been pre-qualified / enlisted the reasons for not pre-qualifying them.
- 19. Minimum relevant services experience is for two years.
- 20. Successfully pre-qualified companies will be issued letter of information for enlistment on the panel of NICL.
- 21. NICL may reject all proposals at any time prior to the acceptance of proposals. NICL shall upon request communicate to any applicant who submitted a bid or proposal, the grounds for its rejection of all bids or proposals but is not required to justify those grounds.
- 22. The Bid Security of unsuccessful applicants will be returned upon award of contract to the successful bidder.
- 23. The bid/Proposal validly shall be for 90 days.
