**TENDER NOTICE**

1. Pakistan Post invites sealed Bids from the Airlines and their authorized Logistics/Transport Partners for transportation of Airmail world-wide and domestic sectors (Including Courier Companies having capacity to offer transportation services to Pakistan Post for International Destinations) for a period of **03-years w.e.f. July 1<sup>st</sup> 2024 to June 30<sup>th</sup> 2027**. The term of the agreement can be further extended through addendum on annual basis if both parties agree to it.
2. The tender document containing detailed terms & conditions can be obtained from the Assistant Director (Quality Service) Room # 14, DGPPPO, Sector G-8/4, Islamabad during office hours before closing date.
3. The bidding shall be done according to "Single Stage-Two envelope procedure" in line with Clause 36 (b) of Public Procurement Rules, 2004.
4. Technical Bids of the authorized Logistics/Transport Partners of the Airlines (Including Courier Companies) must be accompanied with a Bank Draft/Pay Order of PKR.100,000/- as earnest money (Refundable) in favor of Director General, Pakistan Post, Islamabad otherwise the bids will not be accepted.
5. Under the provision of IATA-UPU framework for a postal service agreement, Airlines are required to submit financial bid only. However, their authorized Logistics/Transport partners (Including Courier Companies) are required to submit "TECHNICAL BID AND FINANCIAL BID" separately which should reach the undersigned till **30-05-2024 upto 1030 hours**. As per Rule 36 (b) of PPRA Rules 2004, Technical Bids of the authorized Logistics/Transport partners of the airlines (Including Courier Companies) will be opened on the same day at **1100 hours** and Financial Bids of Airlines and their technically qualified authorized Logistics /Transport partners (Including Courier Companies) shall be opened on a date within the bid validity period in the presence of bidders or their authorized representatives. Bids received after due date and time will not be entertained.
