1. National Highway Authority (NHA) intends to hire services of a Security Company for deployment of Armed Security Guards at its Regional Office Muzaffarabad AJK and its attached Maint. Unit at Muzaffarabad & Murree. Therefore, sealed bids following "**Single stage-Two Envelopes**" procedure are invited from dealing firms having valid NTN Certificates and relevant experience.
2. Registered Companies holding NOC from the Ministry of Interior, Govt. of Pakistan and Home Departments are eligible to apply.
3. Bid Documents for Pre-qualification may be obtained on submission of a written application from the office of undersigned on payment of a non- refundable fee of Rs. 500/- (Rupees Five Hundred only), in favour of National Highway Authority or may be downloaded from NHA website (free of cost).

Bids completed in all respects duly sealed, signed and supported with documentary evidence should be submitted in a sealed envelope containing two separate envelopes for Technical & Financial Proposals on or **before 16.05-2024 at 1130 hours** at below mentioned address. Technical Bids shall be **opened on same day at 1200 hours**. in the presence of the representative of the bidders who may chose to be present. However, Financial Bids of Technically, qualified bidders shall be opened, later, the date of which will be communicated after evaluation and approval of Technical Bids.
5. Technical Bids should accompany Pay Order of **Rs.25,000/-** as bid security (Refundable).
