INVITATION FOR BIDS

(Tender No. PD/FF-2/WASA/FSD)

1. The Islamic Republic of Pakistan has received Financial Support (loan) amounting EURO 33.40 million designed for the “Extension of water Resources for Faisalabad City Phase-I”, and intends to apply part of the proceeds of this loan to payments under the contract for “**Engineering, Procurement, Construction (EPC) and Technical Assistance, on turnkey basis**”. A part of this contract will be funded by local financing (amounting Rs. 1339 million) from Govt. of the Punjab.
2. The Project Director, Project Management Unit (PMU) for French Funded Project, Water and Sanitation Agency, Faisalabad invites sealed bids from French Firms for “**Engineering, Procurement, Construction (EPC) and Technical Assistance on turnkey basis**”. The contract comprises 2-packages (A) and (B) to be funded from French loan and local financing by Punjab Govt. of Islamic Republic of Pakistan respectively, with completion period of 36-months.
3. The firm (bidder) will be selected under the procedures described in the bidding documents (RFP), in accordance with the laws of the Islamic Republic of Pakistan and the Financial Protocol signed between the Government of the French Republic and Government of the Islamic Republic of Pakistan.
4. Bidding documents can be purchased from the Office of Project Director PMU French Funded Project WASA-Faisalabad for a non refundable fee of Rs.250,000/- for each set by January 11, 2012. Interested bidders may obtain further information at the same address. A pre-bid meeting will be held on January 11, 2012 at 2:00 PM at WASA Faisalabad office.

5. Single stage 2-envelope procedure will be used in bidding process. Both Technical and Financial proposals will be submitted by the bidder as detailed in bidding documents.
6. Bids shall be valid for a period of 120 days after bid opening and must be accompanied by Security of at least 2% of bid cost and shall be delivered to Project Director on or before 1200 hours on January 31, 2012, at which time they will be opened in the presence of the bidders who wish to attend.
7. All bidders shall be required to submit with their bids, qualification information specified in the bidding documents. This information shall be used to establish through post qualification whether the bidder is qualified to perform the work.
8. WASA will reject a proposal for award if it determines that the Tenderer recommended for award has directly or through an agent, engaged in corrupt, fraudulent, collusive, coercive or obstructive practices in competing for the contract is question.
