However, original documents of the contractor / firm can also be demanded by the administration for verification. The Cash Deposit receipt of Call Deposit from the scheduled bank as earnest money indicated above and an affidavit, on stamp paper of Rs.100/-, stating that the firm has not been blacklisted or debarred for taking part in bidding by any Government / Semi Government / Autonomous / Semi-Autonomous Bodies of Pakistan must be accompanied with tender documents i.e with Technical bid duly prepared in favour of Divisional Accounts Officer, Pakistan Railways, Peshawar at the time of dropping in the Tender box. The tender will be received upto 11.00 hours on **29.04.2024**. Technical bids will be opened at 11.30 hours on the same date in the chamber of Divisional Accounts Officer, Pakistan Railways, Peshawar in the presence of the bidder or their authorized representative who choose to remain their.
