

## TENDER NOTICE

Sealed single stage--- two envelope bids (Financial Proposal and Technical Proposal) in separate envelopes to avoid confusion are invited from Government approved (G.S.T registered authorized dealers / Agency) along with two samples for each item for the supply of Arsenal Stores items (compatible with existing system) for Frontier Constabulary for the year 2023-24. These must reach this HQRs: on 09/05/2024 till 11:30 hours. which will be opened on the same date at 1200 hours in the presence of bidders by Technical Committee in conference room of CHQ Peshawar. Tender bids with CDR for each item will be given separately in separate sealed envelope instead of all items combined recorded in the tender. Bid security @ of 3% of total value must be submitted with tender (Financial proposal) in the name of Commandant, Frontier Constabulary Khyber Pakhtunkhwa Peshawar in separate sealed envelopes. ### BRIEF TERMS AND CONDITIONS:-

1. All interested firms/contractors can see samples of the said items at Headquarter Frontier Constabulary Ordnance Branch on any working day except Saturday & Sunday from 1100 to 1400 hrs.
2. Quotation received without samples will not be accepted, any firm submitting quotation without sample will lose its chance of competition in respective bids.
3. The Firm's name and trade mark should not be written on samples. Only tags bearing firm's name should be attached
4. Initially only one envelope (TECHNICAL PROPOSAL) shall be opened.
5. Quoted prices mentioned must be inclusive of all taxes applicable.
6. The envelope marked as "FINANCIAL PROPOSAL" shall be retained in the custody of the procuring agency without being opened.
7. The procuring agency shall evaluate the technical proposal, without reference to the price and reject any proposal which does not conform to the specified requirements.
8. During the technical evaluation, no amendments in the technical proposal shall be permitted."

8. During the technical evaluation, no amendments in the technical proposal shall be permitted.
9. After evaluation and approval of the technical proposal, the procuring agency, shall at a time within the bid validity period, publically open the financial proposals of the technically accepted bids only.
10. The financial proposal of bids shall be opened publically at a time, date and venue announced and communicated to the bidders in advance.
11. Under the clause 33(1) in the PPRA Rules 2004 "the procuring agency may reject one or all bids or proposals at any time prior to the acceptance of a bid or proposal without providing any reason. The procuring agency shall upon written request communicate to any supplier or contractor who submitted a bid or proposal, the grounds for its rejection of all bids or proposals but is not required to justify those grounds.
12. The rates approved shall remain valid till 30<sup>th</sup> June, 2024. Only typed on original letter pad, sealed in a manner that cannot be known until opened and signed (every page) should be submitted. The bidders will have to submit their address, land line phone number. Taxes will be charged as per rules.
13. The sample and proposed items must be compatible with existing system in use with Frontier Constabulary.
14. An affidavit on stamp paper that the firm is not blacklisted shall be attached with the documents. Active tax payer certificate from FBR should also be attached.
15. Bidding documents received through fax will not be acceptable. Tender with incomplete supporting documents will not be entertained and furnishing of incorrect /false information shall be liable to legal action.
16. The rate should be quoted on F.O.R basis Frontier Constabulary HQRs Peshawar Cantt: including all taxes.
