All other terms and conditions of earlier published invitation for bid and other clauses mentioned in the Bidding Document shall remain unchanged". The said clause has been amended and incorporated in bidding documents and same can be obtained from USC Head Office or download from USC website i.e [www.usc.org.pk](http://www.usc.org.pk) and PPRA website i.e [www.ppra.org.pk](http://www.ppra.org.pk), whereas, tender opening date has also been rescheduled and now, is to be opened as on 06.03.2024 at 02:00 PM.

# تصحیح برائے ٹینڈرنوٹس

ادارہ ہذا کے 17.02.2024 کو اخبارات میں شائع ہونے والے اشتہار برائے خریداری چاول بحوالہ PID نمبر (1) 4889/23 اور پی پی آر اے نمبر TS532706E، کو بولی کی دستاویزات کی شق 37 (a) کو درج ذیل ترمیم کے ساتھ پڑھا اور سمجھا جائے۔

بولی کے دستاویزات کی شق 37 (a) میں کی گئی ترمیم یوں ہے:

"چاول سپلائی کے لئے مامور افراد کو مال کی قیمت کی ادائیگی خریداری نامہ کے مطابق مطلوبہ مقدار میں اور بتائے گئے مقام پر چاول کی مکمل اور تسلی بخش فراہمی کے بعد انوائسز یا رنگ بل بمعہ وزن کاٹنا کی پرچی، گودام میں موصولی کی رسید جو کہ گودام انچارج سے تصدیق شدہ ہو اور متعلقہ علاقائی مجاز افسر سے منظور شدہ ہو، جمع کرانے پر کی جائے گی۔ اس کے علاوہ معاہدے میں درج شرائط کو بھی 30 دن کے اندر پورا کرنا لازم ہے جس میں توسیع کسی صورت نہیں ہو سکے گی۔ بولی دستاویزات میں دی گئی دیگر شرائط و ضوابط بدستور رہیں گی جو کہ پہلے سے شائع شدہ ہیں۔"

**TENDER NOTICE FOR PURCHASE OF RICE**

1. Utility Stores Corporation of Pakistan, invites sealed Tenders/bids for supply of Tota Super Basmati Rice, Super Basmati Rice, Sella Rice (Kainat 1121) & Rice 386 packed in 1 kg, 2kg, & 5 kg crystal/transparent poly bags from Rice Mills/Processing Units and Rice Suppliers/Traders and Vendors registered with Income Tax /Sales Tax Departments. Evaluation of packed Rice will be done based upon the cost of packing material + allied charges.

2. The quantity required to be purchased and delivered at each station, complete terms and conditions of bidding are contained in the tender documents, which can be downloaded from PPRA website i.e. [www.ppra.org.pk](http://www.ppra.org.pk) and USC website i.e. [www.usc.org.pk](http://www.usc.org.pk) and can be collected free of cost from USC Head Office, Islamabad and USC Zonal Offices. A separate Demand Draft/Pay Order of Rs.2,000/-(non-refundable) in favour of USC on account of tender fee in lieu of printing and provisioning of documents be attached at the time of submitting bid/offer. Interested eligible bidder may obtain bidding documents from USC Head Office Islamabad and USC Zonal Offices during office hours.

3. Bidding shall be conducted through open competitive bidding by adopting PPRA Rule 36 (a) single stage- one envelope procedure of the Public Procurement Rules - 2004. Sealed bids offers along with 13kg and ½ kg separately sample must be delivered to the below office on or before **04-03-2024** on **Monday** at **12:00 PM**. Proposal must be accompanied by a bid security at the rate of 2% of the estimated value of procurement determined by the USCP being a procuring agency as mentioned in the bidding documents in the form of Pay Order duly issued from a scheduled Bank of Pakistan. Bids will be opened on **4<sup>th</sup> March, 2024** at **12:30PM** in the presence of bidders or their representative at USC Head office Islamabad. Bids not complying with the requirements shall be rejected being non-responsive. Alternate proposals and /or conditional bids shall be considered non-responsive. Taxes will be deducted as per applicable government rules. NTN and Sales Tax registration certificates must be provided with the Bid. Bids which are incomplete, not sealed, not signed and/or not stamped, late or submitted by other than specified mode will be rejected. In case of any holiday announced by the Government the tender will be opened on next working day at the same time.

An affidavit on legal stamp paper in original worth Rs. 100/- to effect that the bidder has not been blacklisted by any Government/Semi-Government/Autonomous organization and there is no litigation pending adjudication in any Court of Law. The pre-bid meeting will take place as prescribed in the tender documents.
