- a. Payment will be made through CMA Lahore.
- b. Rates should be quoted with all Government Taxes including GST.
- c. Non conforming store will be rejected by ASID in bulk or in parts.
- d. No advance payment shall be made by the ASID Lahore.
- e. Validity of rates / offer upto **30 Jun 2024**.
- j. All rights to accept / reject any or all the tenders are reserved with the Army Stores Inspection Depot Lahore.


2. **Purchaser's Right**. Purchaser does not pledge to accept the lowest or any tender and reserves the right of accepting the whole or any part of the offer made.

3. **Withdrawn of Offer**. If a bidder / firm withdrawn its offer within validity period the competent authority i.e. Assistant Director, Army Stores Inspection Depot may place such bidder / firm under. Embargo or blacklist the name and his bid security / earnest money will be forfeited.

4. **Pre-qualification of Firms / Supplier / Contractors**. Registered and un-registered firms' suppliers with ASID can participate in the tender inquiry.
