This tender is for the procurement of Fortinet License & Forticare subscriptions for hardware that is currently owned by First Women Bank Limited.

- The bidder should be **NTN** and **GST** registered company in Pakistan.
- The bidder must be minimum **"Select Partner"** of the required product and must include a certificate from Fortinet.
- The bidder must have an annual turnover of PKR 100 million, and must include audited financial statements within "Technical Proposal" envelope.
- The Bidder should have experience of supplying Fortinet License & Forticare subscriptions for at least 4 clients with at-least five Fortinet equipment / per order for in last 3 years. Relevant purchase order or copy of signed contract must be submitted
- The Bidder must have active at least 2 network resources. Please attached network resources resume along with certificate proof.
- The bidder must have been in operation for at least five years in related to supply, configuration and commissioning of network equipment.
- Those bidders who conform to technical specifications & requirements including terms & conditions of the contract shall be eligible for award of contract.
- Bidder to provide an affidavit on a stamp paper confirming compliance with the following terms in order to be eligible for participation against this RFP

o Bidder or any of its associated Parent / Affiliated / Subsidiary company should not have been blacklisted from participating in any public sector bids / RFPs / tenders.
