- Pakistan Industrial Development Corporation (PIDC), a government-owned company under the administrative control of the Ministry of Industries & Production, intends to sale vehicles on 'as is where is' basis. Interested Bidders/parties are requested to quote their rates for each vehicle or multiple vehicles.
- Vehicle Token Tax for all listed vehicles is paid up to **30.06.2024**. Successful bidder(s) will bear the transfer charges.
- All bids must be accompanied by a Bid security (refundable) of an amount equal to 2% of bid price in the shape of Demand Draft / Pay Order in name of Pakistan Industrial Development Corporation (PIDC). All bid securities will be returned to non-eligible bidders after the announcement of the evaluation result, whereas the bid security of the successful bidder(s) will be returned after submitting documentary proof of initiation of vehicle transfer process, the process should be initiated by the successful bidder within 15 days after receiving a transfer letter by procuring agency. In case of failure, bid security will be forfeited.
- It's mandatory for successful bidder(s) to submit evaluated bid price (as stated in letter of acceptance) in the account of Pakistan Industrial Development Corporation (PIDC) in the form of Demand Draft / Pay Order within 15 days of issuing of letter of acceptance.
- Bidder has a right to submit their bid for a single vehicle or multiple vehicles. Sealed bids should be clearly marked with the name of the bidder, address, and title of the procurement. A list of vehicles can be downloaded from PIDC website www.pidc.com.pk or PPRA website www.ppra.org.pk.
- Parties / Bidders are requested to submit their sealed bids at the below-mentioned address on or before 23rd May 2024, up to 11 a.m. along with the copy of valid CNIC and original Pay Order of Bid Security. All bids will be opened on the same day at 11:30 a.m. in the presence of representatives of the firm who may wish to witness the opening of sealed bids.
- After Evaluation, most advantageous bid (highest ranked bid) for each vehicle will be accepted.
- The bid should be inclusive of all applicable Govt. taxes.
- All bidders must disclose in writing in cover/submission letter, at the time of bid submission, if the bidder has any relatives or acquaintances working in the PIDC.
- In case the last date of submission of bids falls on closed official day(s), the date for the submission and opening of bids shall be the next working day.
- The procuring agency reserves the right to accept or reject any or all bids as per PPRA rules.
