EXPRESSION OF INTEREST

1. Skill Development Trainings (Tec-based trainings and vocational trainings) are an initiative by Government of Gilgit-Baltistan to promote gender equality and women empowerment. The Programme is specially designed for the unemployed women so that they can obtain freelancing training to enhance their skills, which will allow them to earn an honorable earning online and shall facilitate in a secure livelihood in the long term.
2. Women Development Department Government of Gilgit-Baltistan has launched a program "Skill Development Trainings (Tec based trainings and vocational trainings) under the Project "Capacity Building of Women in Demand Driven Trades in Gilgit Baltistan" ADP #508".
3. Women Development Department will establish training centers in 05 Districts of Gilgit Baltistan i.e Gilgit, Skardu, Astore, Hunza and Nagar, equipped with required machinery and equipment. Whereas for the technical support/trainings/HR, Women Development Department GB requires bids from eligible consultant firms/Registered NGOs that have relevant experience in this field can get the tender documents on payment worth of Rs. 5000/- (**non refundable**) from this office and participating Firms are requested to submit Technical and financial proposal separately in **sealed envelopes in accordance with GB PPR 2022 i.e. single stage two envelope procedure.**
4. As per PPRA rules, at least 2% call deposit (CDR) of bid amount from any schedule bank including KCBL in the name of Deputy Director Women Development Directorate GB may be attached with the Technical Bid/ Tender. In case, original CDR not found attached with the Financial Bid, the Firm/Contractor will be declared as "**Non-Responsive**". Successful Bidders will have to submit **10% performance Security** of total bid price in the name of Women Development Directorate GB within 07 days after bid acceptance.
5. Final date for submission of Technical/Financial Proposals is 25th March, 2024 till 10:00 AM and will be opened on the same day at 11:00 am in the presence of bidding firms.
6. The Department reserves the right to reject all the proposals as per PPRA Rules or cancel the bidding without assigning any reason.
7. Bid Documents (detailed procedures) can be obtained from the office of Women Development Department, Sakwar Gilgit during office hours.
