

CONDITIONS OF CONTRACT

FOR OTHER WORKS:

(Before quoting rates, the bidders can visit the site).

1. The rates quoted shall be for complete finished work including labor. All kind of material used, will be the responsibility of contractor.
2. No advance payment will be made at any cost.
3. The work shall be done according to satisfaction of SNGPL.
4. Mobilization of Staff, Tools and Material.
- 4.1.1 The contractor shall be required to mobilize the material, tools & staff to site and start the work within 07 days of placement of work order to him.
- 4.1.2 Contractor shall be responsible of site Clearance / Shifting of debris & Waste material after completion of job.
- 4.1.4 The entire job shall be completed within 60 days after receiving work order. It may please be noted that a penalty of Rs. 1000/- per day shall be levied for each day the work remains incomplete after the specified date. Maximum penalty not to exceed 10% of the contract amount.
5. SNGPL is the sole judge to approve the standard of the work and if bad workmanship is detected, the contractor shall rectify all such defects at his own risk and cost including material
6. All applicable taxes (including income tax, PST, GST etc) will be deducted as per Government Laws.
