2. **Single Stage Two Envelop Bidding Procedure** of Principal Method of Procurement (i.e. Open Competitive Bidding) will be used by adopting **Least Cost Based Selection (LCBS) Technique** for the subject procurement, in line with the Public Procurement Rules, 2004 and any Regulations, Regulatory Guides, Procurement Guidelines or Instructions issued by the Authority (from time to time).
3. All Proposals must be accompanied by a Bid Security mentioned in the Bidding Documents (Refundable) in shape of Bank Draft / CDR in the name of **DDO NHMP West Zone Quetta**. The Bidder shall submit scanned copy of Bid Security on EPADS and original Bank Draft/CDR will be submitted to the Logistics (store) Branch NHMP West Zone before opening of the tender.

Bidding documents are available at **NHMP and EPADS website free of cost** OR can be obtained from the office of the DIG / Zonal Commander West Zone, (Logistics / Store Branch), NHMP during office hours before the closing date, on the payment of Pak Rupees One thousand (PKR=1,000/-) in shape of Pay Order in the name of the **DDO NHMP West Zone** (non-refundable). Cheques will not be acceptable.
5. In case opening date(s) is declared as a **Public Holiday** by the Government, the next working date shall be deemed to be the date for submission and opening of tender(s) at the same time and place.
6. The Bids will be received only from those firms who are registered with PPRA **for e-procurement on EPADS** for Tendering through Email addresses which were provided by them to PPRA at the time of their registration.
