Tenders will be issued to the scrutinized contractors up to **27-05-2024** Tenders must be dropped / delivered in Black Box placed at Bid Centre (Rabta Hall) near Gate No. 01 on **30-05-2024** up to 1030hrs. Tenders will be opened on the same date at 1100hrs. In case of public holiday, tenders will be received on next working day upto 1030hrs opened at 1100 hrs on same date.
