## **INVITATION TO BIDS**

The outer letter shall clearly be marked with Tender Enquiry No. for which the proposal is submitted. Financial Proposal of bids found technically non-responsive shall be returned un-opened to the respective bidder along with submitted Bid security.
4. Bid Security equivalent to 02% of total bid price in shape of CDR. Pay Order/Demand Draft issued from any scheduled bank of Pakistan is required to be deposited with Technical Proposal.
