

Method of selection will be Single Stage-Two Envelope (SSTE) bidding procedure, as per Clause 36(b) of Public Procurement Rules 2004, amended up to date. Tender documents can be purchased from office of the Executive Engineer, Central Civil Division-III, Pak PWD G-9/1, Islamabad after the publication of this notice up to **25-04-2024** during office hours against the non-refundable cash payment of **Rs. 2,000/-** each. The tenders will be received on **26-04-2024** latest by 2:00 PM and will be opened on the same date in the presence of bidders/authorized representatives, who may choose to attend at 2:30 PM at the same address.

TERMS AND CONDITIONS:

1. Tenders will be issued upon submission of official application on original letter head of the company and upon satisfaction of requirement.
2. Proof of being on Active Tax payers List/NTN Certificate.
3. Copy of National Identity Card (original must be provided at the time of submission of application)
4. Copy of PEC enlistment /registration in the relevant category & financial limit.
5. Bid security in the shape of Deposit at call in the favor of Executive Engineer, Central Civil Division-III, Pak. Public Work Department Islamabad issued by any scheduled bank functioning at Islamabad/Rawalpindi from the account of applicant/firm must be submitted.
6. Tender will be issued to the contractors themselves or authorized representative of Contractors/Firm. The representatives must present registered special power of attorney in their name in order to purchase the Tender Documents.
7. All the applicable Federal Provincial taxes must be considered while preparing the bids and shall be considered included in the quoted rates.
8. Undertaking on stamp paper of Rs. 100/- that the firm / contractor has neither abandoned any work nor black listed in any Department, along with Certificate that the particular / information furnished are true and correct duly signed by the Notary Public.
9. The submission of tender by the contractor implies that he is fully conversant with the site of work, scope of work and terms and conditions laid down in the tender documents.
10. Conditional tenders will not be acceptable.
11. 1st, 2nd, 3rd, lowest bidder's CDR will be retained till acceptance of tender and will be refunded after acceptance of tenders, through Government Cheque after its crediture in Government Account.
12. Tenders through post/tax/telegraphically/E-mail shall not be entertained.
13. Under rule 33 (i) of Public Procurement Rules, 2004. Pak PWD reserves the right to reject the bids at any time prior to the acceptance of bid.
