Scaled Tender is required to the undersigned for the Supply of Feeding Charges for Govt. Horses of FRP HQrs: Peshawar for the financial year 2024-25.


Detail of feeding Charges are as under:-

- i. Dry crashed Maize (Juar - without water) 9.072 KG and green gram 22 KG per Horse.
- ii. Crushed gram 1.361 KG
- iii. Chokar 1.134 KG
- iv. Duly thrashed gram (Dalaya) 2.040 KG
- v. Salt 0.028 KG
- vi. Hayrick 1.361 KG
- vii. Iron Clip for the legs per horse once in a month (Quantity 4 No's)
- viii. Hair cutting per horse once in a year.

Cost estimate approximately Rs. 9,000,000/-

Conditions:

1. Every item of the ration shall be mentioned separately
2. Grinding machine will be the property of their own bidder
3. The following documents duly attested must be attached with the tender
 - i. Income Tax Certificate with CNIC photocopy.
 - ii. Five years experience Certificate of Feeding Supply for horses with any Govt: Department.
4. Tender of the above must reach to this office on 05-06-2023 before at 11:00 am, which will be opened in the presence of the Bidder on the same day at 02:00 pm. The agreement duration will be up to 30-06-2025.
