
The Rules Corner

Public Procurement Rule No. 15. Pre-qualification of suppliers and contractors.

- (1) A procuring agency, prior to the floating of tenders, invitation to proposals or offers in procurement proceedings, may engage in pre-qualification of bidders in case of services, civil works, turnkey projects and in case of procurement of expensive and technically complex equipment to ensure that only technically and financially capable firms having adequate managerial capability are invited to submit bids. Such pre-qualification shall solely be based upon the ability of the interested parties to perform that particular work satisfactorily.
- (2) A procuring agency while engaging in prequalification may take into consideration the following factors, namely:-
- (a) relevant experience and past performance;
- (b) capabilities with respect to personnel, equipment, and plant;
- (c) financial position;
- (d) appropriate managerial capability; and
- (e) any other factor that a procuring agency may deem relevant, not inconsistent with these rules

Monitoring and Implementation:

The monitoring of tendering through by PPRA website is a continuous process. The IT wing indicates the violations of PP Rules made by procuring agencies. The process of monitoring helps enable the procuring agencies to remove the violations in future tendering. The data for the month of December 2009 is depicted in the graph.

PPRA with its teething ills of non comprehension and the rough and tumble of turf and unfulfilled desire of the interested to do away or take over, PPRA appears to have come of age and definitely here to stay in its pristine form. PPRA is sans claws, sans teeth but full in help, advice, compassion and building capacity. This issue contains information on what we did in the last year with an eye on tomorrow.

PPRA PERFORMANCE IN THE BYGONE 2009

- 1. PPRA PUBLISHED ITS FIRST ANNUAL REPORT (2002-2008) SINCE ITS INCEPTION.
- 2. BROUGHT OUT NO-COST MONTHLY PPRA GAZETTE.
- 3. ESTABLISHED NATIONAL INSTITUTE OF PROCUREMENT IN PPRA BUILDING, IT IS AN IN HOUSE TRAINING ROOM AND A LOUNGE FOR THE PARTICIPANTS, SAVING MILLIONS AS OF RENT.

Findings of 1st Impact Evaluation Survey-PPRA:

The survey elicited perceptions of various stakeholders on major functions like grievances rederessal, capacity building, monitoring mechanism, PP Rules 2004 and transparency. Overall survey results indicate that the creation of PPRA has been helpful in introducing the new culture of public procurements in the country, in terms of awareness, professionalism and transparency. Response to various aspects transpire:

Transparency: Overall 87% respondents believe transparency has improved in the public procurements. Further break-up of responses indicate that 89% procuring agencies, 92% trainees, 65% bidders/suppliers and 13% international organizations agree that transparency in public procurements has improved.

Capacity building: Over 98% of the respondents have shown great satisfaction over the achievements of the project. The level of satisfaction of 32% have been very high, 65% high and only 3% had low satisfaction. The majority of international organizations (67%) of the respondents reported that capacity building program has been successful in achieving its objectives to a great extent. In respect of learning of PP Rules 100% respondents perceived that the training program has been helpful in learning these Rules.

On the other hand, respondents have also pointed out the weaknesses of the training program and 20% felt that topics were not covered fully, 23% were not satisfied with schedule, 12% showed their concern about facilitation/logistics and 7% were not satisfied with

communication skills of lecturers. This feedback would be helpful in the improvement of the training program of PPRA.

Monitoring: About 75% respondents are satisfied with the monitoring mechanism of PPRA, 93% agencies agreed that due to the monitoring they have improved the compliance of PPR Rules, 92% say that the uploading of tenders have also

been helpful in reducing the tendering cost.

Grievances Redressal: 81% of the respondents reported that they got proper and swift response from the Authority in respect of processing of their complaints. However, the effectiveness of Rule 48 has been perceived by the bidders differently and majority of the bidders remains unsatisfied as only 16% were satisfied with the dispute resolution mechanism under Rule 48 and majority of the bidders want more powers with PPRA in order to resolve disputes

PPR Rules 2004: According to 77% of the overall respondents the PP Rules 2004 adhere to or proximate to international best practices. According to details 93% procuring agencies, 82% trainees and 80% respondents of international organizations have shown satisfaction over the PP Rules in comparison with international best practices.
