# Pakistan Becomes Observer to Agreement on Government Procurement (GPA)

In recognition of legal framework of public procurement being compliant to international standards, Pakistan has been accorded the status of "Observer" to the Agreement on Government Procurement (GPA). Pakistan has already undertaken domestic procurement reforms and has developed a strategy for achieving a "fair, transparent, efficient and effective" public procurement regime. The current Parties to the plurilateral GPA are: Armenia, Canada, the European Union (with its 28 member states), Hong Kong-China, Iceland, Israel, Japan, Korea, Liechtenstein, Kingdom of the Netherlands with respect to Aruba, Norway, Singapore, Switzerland, Chinese Taipei and the United States.

Japan, the EU, the US, Canada, Norway, Hong Kong-China, Chinese Taipei and Switzerland welcomed Pakistan's decision. Members of GPA hoped to soon receive Pakistan's application for its accession to the GPA.

Ms. Nazrat Bashir, Managing Director, PPRA, in her welcome address, besides appreciating achievements of Mr. Ata Ur Rehman, recalled that Massive Open Online Course (MOOC) was inaugurated by the President of Pakistan during the Regional Conference of South Asian Countries held early last year. She also lauded the initiative of World Bank to train public procurement officials using information technology.

### 1278 Letters Indicating Violations Issued to Procuring Agencies

During January - March, 2015 the Procuring Agencies uploaded 8517 tender notices on the PPRA website. On scrutiny of the tender notices, it was found that 1278 tender notices were in violation of the Public Procurement Rules, 2004. As a standard procedure, all the procuring agencies were informed about the violations and were advised to rectify to make the tender notices in accordance with the provisions of the Rules.

Maximum violations committed by the procuring agencies related to Rule 13 (Response Time) and Rule-28 (Opening of Bids). The percentage of compliance of Public Procurement Rules, 2004, on indicated violations by PPRA, was 11 %.

PPRA is providing necessary guidance to all procuring agencies and the bidders in response to their emails, letters, online queries and telephonic clarifications as mandated under PPRA Ordinance, 2002.

A total of 36 guidelines letters were issued to different procuring agencies and bidders during January - March, 2015. In addition, 131 online queries relating to various steps of procurement proceedings were also responded through PPRA Online Query System.
