## **IMPORTANT NOTES:-**

- a) Experience/ Educational Qualification shall be counted / examined as on the closing date for receipt of applications.
- b) Only shortlisted candidates shall be called for test/ interview, after scrutiny of applications.
- c) Candidates with additional qualification / experience may be preferred. However, no additional allowance will be permissible.
- d) Hiring will be governed by the terms of services of hiring contract.
- e) Candidates possessing dual / foreign nationality are not eligible to apply.
- f) No TA/DA will be admissible for appearing in test/interview.
- g) Final selection will be subject to Security Clearance.
- h) Selected Law Officers will be required to serve at NAB HQ or any Regional Office of NAB.
- i) Private practice shall not be allowed to the selected Law Officers.
- j) The monthly fee is taxable as per Federal Govt. policy.
