8. Calibration certificate/methodology of calibration of logger is also required.
9. Technical Comparison is needed to be submit along with bids, keeping in view tender specifications.

11. All firms having non-availability of above said specifications in their equipment will be rejected.
12. No advance payment will be made by NESPAK. Payment will be released within eight weeks of supply of approved stock as per purchase order.
