4. Earnest Money **40,000/-** in the shape of Pay Order/Bank Draft of any scheduled Bank drawn in favor of "Civil Aviation Authority" should be submitted along with the tenders in sealed envelope. Tenders without earnest money would not be entertained. Pay Order / Earnest Money of the unsuccessful bidders will be retained till finalization of tender process.
5. No tender will be sold by post or on the date fixed for opening of tenders.
6. Tenders will be issued only to those Contractors/Firms who will have Professional Tax Clearance Certificate issued by Excise Taxation & Narcotics Control Department.
