

TENDER NOTICE
GOVERNMENT OF PAKISTAN
MINISTRY OF NARCOTICS CONTROL
HEADQUARTERS ANTI NARCOTICS FORCE RAWALPINDI

1. This organization requires sealed tenders from interested /capable General Sales Tax (GST) holder firms / organizations / Companies for purchase and installation of Solar Energy System (400 KW On-Grid) at HQ ANF, Wavel Lane, Opposite Old Airport, Chaklala, Rawalpindi. Detailed tender documents may be obtained from Headquarters ANF Rawalpindi (Signal Section) on cash payment of Rs.1000/-. For further clarification, site survey may be carried out before finalization of bids documents:-
 2. **Terms & Conditions**
 - a. Bids may be submitted on the address in a SEALED CONFIDENTIAL Envelop latest by **15 May 2024 (Wednesday) before 1100 hours**. No tender will be accepted after cut down date and time. The bids will be opened on the same date at **1200 hours**.
 - b. A bid bond, in the shape of a Bank Draft / Pay Order in the name of HQ Anti Narcotics Force, Rawalpindi amounting to Rs.5% (Refundable) of total cost should be submitted along with tender as security deposit.
 - c. All the proposals and prices shall remain valid upto **31 Dec 2024**
 - d. All currency in the proposal shall be quoted in Pakistan Rupees (PKR) including all taxes.
 - e. The bidder is hereby informed that the Government shall deduct taxes at the rate prescribed under the tax laws of Pakistan, from all payments for services rendered by any vendor who signs a contract with the Government.
 - f. Bidder should clearly indicate the duration of delivery / installation of solar system after the award of contract. **An agreement / contract will be signed with the successful bidder on stamp papers mentioning details terms & conditions of the work.**
 - g. Proposals shall be delivered by hand or courier so as to reach the address given below before closing date and time. **PROPOSAL RECEIVED BY FAX OR EMAIL SHALL NOT BE ACCEPTED.**
 - h. The successful bidder will have to deliver and install the solar system as per our schedule, failing which, order will be cancelled and earnest money will be forfeited in favour of HQ Anti Narcotics Force. **The bidder will also be declared black listed.**
 - i. HQ Anti Narcotics Force, Rawalpindi reserves the right to reject all bids or proposal at any time prior to the acceptance of a bid or proposal. The procuring agency shall upon request communicate to any supplier or contractor who submitted a bid or proposal, the ground for its rejection of all bids or proposals, but is not required to justify those grounds.
 - j. HQ Anti Narcotics Force, Rawalpindi will announce the results of bid evaluation same day in the form of a report giving justification for acceptance or rejection of bids at the time of awarding of procurement contract.
 - k. The bidder should submit his technical and financial bid separately into envelops. Technical bid should contain the technical expertise held with the firm, their past experience and any projects related to the tender under taken. Financial proposal should contain the rates of the work to be under taken. Financial bids will only be opened after opening of technical bids. Financial bids of only technically qualified bidders will be opened. Financial bids of unqualified bidders will be returned un-opened.
 - l. Bidder should forward proposal in accordance with guideline/regulation issued by NEPRA.
 - m. All bidders participating in the tenders should be registered with FBR and must be included in active tax payer list maintained by FBR. Also produce following documents alongwith technical bid:-
 - (1) Affidavit of black list on stamp paper of Rs.100/-
 - (2) Past Experience Certificate / projects undertaken / completed and any project in hand.
 - (3) Bank statement of last 6 months.
 - n. The participating bidders are requested to carry out the survey of the site of HQ ANF, Wavel Lane, Opposite Old Airport, Chaklala, Rawalpindi with prior coordination with Deputy Director (Technical) of HQ ANF Rawalpindi during office hours on any working day. The bidders should study and carry out the detailed survey of the site and make feasibility of delivery and installation of solar system.
 - o. Payment of work will be paid to successful bidder to AGPR cheque after 100% completion of work.
 - p. Existing electricity meter connection at HQ ANF is industrial type C-2b(29)T, which needs to be converted for net metering.
 - q. Earthing, protection lightening and surge protection arrangement will be the responsibility of the successful bidder in accordance with guidelines issued by NEPRA.
 - r. Successful bidder will provide replacement warranty of 25 years for solar panels and 5 years repair/replacement warranty for solar inverters.
