All currency in the proposal shall be quoted in Pakistan Rupees (PKR) including all taxes. d.

- The bidder is hereby informed that the Government shall deduct taxes at the rate prescribed under the tax laws e. of Pakistan, from all payments for services rendered by any vendor who signs a contract with the Government.
- Bidder should clearly indicate the duration of delivery / installation of solar system after the award of contract. An agreement / contract will be signed with the successful bidder on stamp papers mentioning details terms & conditions of the work.
