Firm that has completed at least Two (02) Contracts (but not more than one Contract summed up for their values in this regard for each completed contracts) of similar size and complexity as a contractor or management contractor (but not as Sub-Contractor) with a minimum value of **Rs. 117.00 Million** each during last Seven (07) years. In case of JV, if Lead Partner alone fulfils the condition, then the other partner is not required to fulfil the condition, otherwise each member shall be assessed according to its share in JV.

- ii) Has an Average Annual Construction Turnover of minimum Rs. 465.00 Million. In case of JV each partner must fulfill the Criteria with respect to its share in the JV Agreement.
- iii) Has a minimum Cash Flow of Rs. 117.00 Million. In case of JV each partner must fulfill the Criteria with respect to its share in the JV Agreement.
