Now these presents witness and the parties here to agree to the terms & conditions as follow:-

- 1. In this Contract words and expressions shall have the same meanings as are respectively assigned to them in the Contract and bidding document of tender No. ZTBL-11-2021 referred to.
- 2. The following documents shall be deemed to form and be read and construed as part of this Contract, viz.:
 - a. the Letter of Intent to the Supplier for Award of Contract;
 - b. the Acceptance Letter submitted by the Supplier
 - b. the Bid Submission Sheet, the Price Schedules submitted by the Supplier.
 - c. the Technical Specification submitted by the Supplier in their bid
 - d. the communication by the supplier through email or letter wherein the supplier has agreed to any purchaser's demand or condition which was not mentioned or partially mentioned in the supplier's bid
 - e. the Bidding Document of Tender No. [ZTBL-11-2021]

8. Disputes Resolution:
