### ARTICLES OF AGREEMENT

The following documents which, for the purpose of identification, have been signed by **Mr. Muhammad Iqbal Mallah, CEO** on behalf of the **Contractor**, and by **Ahmed Rajpar, Executive Engineer (Development)** on behalf of the **University**, which shall be deemed to form and be read and construed as a part of this Agreement viz.:





- a) Articles of Agreement;
- b) Instructions to Tenderers;
- c) Conditions of Contract;
- d) Contractor's Offer including the relevant correspondence prior to signing of this Agreement with all Annexures duly filled in;
- e) The specifications of the food items; and
- f) Bill of Quantity with prices.






