

CONTRACT AGREEMENT



The Employer hereby covenants to pay the Contractor, in consideration of the execution and completion of the Works as per provisions of the Contract, the Contract Price or such other sum as may become payable under the provisions of the Contract at the times and in the manner prescribed by the Contract.
- The Employer/Engineer has the right to delete or add any item of work under this Contract.
- 6. All equipment/material supplied shall be as per approved manufacturers list issued at the time of tender.
- 7. All material arriving at site shall be secured under your custody. Any rejected material shall be promptly removed from site.
- 8. Agreed completion time for the work is 12 months from the date of issuance of letter/notice to Commence by the Employer/Engineer.
- If dismantling of civil work will require, the HVAC contractor will restore it in its original condition at his own cost
