## Notice Inviting E-Tender

The Cantonment Board Multan, Corporate Body and Municipal Authority, invites electronic bids from the well reputed eligible firms/suppliers/manufacturers registered with Income Tax / Sales Tax Departments, who stand at Active Taxpayers List of the Federal Board of Revenue and Cantonment Board Multan being entity for electronic bidding, for supply of following items for Cantt Public School & College, Multan Cantt: -

- The quotations/tender should only be submitted electronically online on or before 21<sup>st</sup> March, 2023 at 12:00pm through E-Tender portal of ML&C Deptt (<https://etender.mlc.gov.pk>) which will be opened on the same day electronically at 12:30pm. The contractors will be able to see comparative statement online.
- The bidder shall submit 2.5% bid security of the estimated cost, sealed in envelop in the shape of call deposit at (original) only through courier before closing date and time.
- Electronic bids should be submitted electronically on or before the fixed date / time.
- The bidder can register themselves with Cantonment Board Multan at [etender.mlc.gov.pk](http://etender.mlc.gov.pk) for online bidding one day prior to the last date of submission of the electronic bids.
- Electronic bids will be valid for 3 months and rates shall be inclusive of FOR destination. Tax liabilities will be in accordance with the law.
- In case the bid is less than 10% of the estimated amount, the lowest bidder shall have to deposit standing security (refundable after successful completion of the work) i.e a reasonable amount decided by the Cantonment Executive Officer in the shape of Call


deposit within 07 days. In case of failure the already deposited 2.5% earnest money shall be forfeited and bid will be cancelled.

8. The work / supply order will be issued on the availability of the required funds to the lowest bidders, after due approval.

9. Call deposit of scheduled banks shall be acceptable from the respective bank account of the bidder.
