1. Sealed bids are invited from local importers/suppliers of Dentistry related Dental Materials / items only for **CLOSE FRAME WORK AGREEMENT** by AFID Rwp for purchase of Dental Materials by MDC's & MDU's for FY 2024-25. The list of items required along with terms and conditions of supply can be obtained from procurement cell of Armed Forces Institute of Dentistry Rwp during working hrs on presentation of following documents: -

a.	Registration Letter of DGDP or DRAP	b.	FBR Registration with valid NTN & Sales Certificates
c.	Bank Statement of Last 3 months	d.	Import Certificate or Authorized Distributor Certificate
e.	Professional Tax Certificate	f.	Experience Certificate
g.	Certificate that Name of the Vendor is Present in the Active Tax Payer List	h.	FBR Active Income Tax and GST Certificate.

2. The supplier must be registered with **DGDP Army or DRAP** and should have security clearance from concerned military authorities and must not be blacklisted or associated to the blacklisted firm.
3. Only those suppliers can submit quotation who are sole agents or authorized distributors of Dental Materials / Dental items and registered for National Tax and Sales Tax with Govt of Pakistan.
4. Complete quotations (**Technical and Financial**) are required to be submitted in separate sealed envelopes to this office clearly indicating the name of supplier, date of submission and words "**Technical Quotation**" and "**Financial Quotation**" till **22 Apr 2024 at 09: 30 AM**. Technical bids will be opened in Conference Room / Auditorium AFID Rwp on same day i.e. **22 Apr 2024 at 10:00 AM** in the presence of authorized representatives of suppliers.
5. Rule 33 (1) – The procuring agency may reject all bids or proposals at any time prior to the acceptance of a bid or proposal. The procuring agency shall upon request communicate to any supplier or contractor who submit a bid or proposal, the ground for its rejection of all bids or proposal, but is not required to justify those grounds.
6. Country of manufacturer of **dental materials** should be as per standard of USA, Europe, Japan and Australia.
7. Dental Implant, Ortho appliances, Maxillofacial plates & screws should be as per standard of USA, Germany, Japan, Italy, Korea and Switzerland.
8. Country of manufacturer of **disposable items of section-10** should be as per standard of USA, Japan, Europe, Australia, Pakistan, China and Malaysia.
