1. With reference to above PQ Notice, it is to inform all concerned that the earlier procurement process for the above mention work has been **annulled** by the competent authority.
2. **National Highway Authority (NHA), Ministry of Communications, Government of Pakistan re-invites** e-applications from the Contractors, registered with Income Tax and Sales Tax Departments and who are on Active Taxpayers List of the Federal Board of Revenue and registered with Pakistan Engineering Council in Category with Specialization as mentioned above for the year 2023-24 for **prequalification of above work**.
3. The procurement shall now be done through NHA e-Bidding System (Enhanced Version). Constructors having valid PEC registration are required to create their fresh "On-line User Account" for participation in the bidding of Maintenance Works. User Guide illustrating the steps to create "On-line User Account" is available on home page on NHA e-Bidding website at www.ebidding.nha.gov.pk. Access to 'NHA e-bidding system' for bidding will be granted upon submission for pre-requisite documents as per guide line. PQ applications submitted, by using NHA e-Bidding system, will only be considered, whereas other applications will be rejected. User Guide and video tutorial are also available on homepage of NHA e-Bidding website.
4. Prequalification documents containing detailed terms and conditions will be available from 10th October 2023 and can be downloaded free of cost from NHA website (www.nha.gov.pk). Applicants are also advised to follow NHA website for updates of schedule and addendum(s) if any.
5. The e-Applications must be prepared and submitted through NHA e-Bidding System in accordance with the instructions contained in the Pre-qualification documents. Hard copy of e-Applications prepared through NHA e-Bidding along with 2% bid security (**Mandatory**) in favour of **General Manager (S-2/S-3 & IMDC) NHA Muzaffarabad**, must reach at address mentioned below on or before **October 26, 2023 till 1130 Hours**. Proposals will be opened on the same day at **1200 Hours**.
